With reference to structural audit report and related conclusion provided by reference 2 above for the building in reference 1 above, it is certified that buildings under consideration is fit for use as current occupancy as school building which was constructed in 2019.

The original design and drawings records of the structure were not available for inspection. Therefore, Structural Audit in reference 2 above was got carried out. Primary inspection reveals that requirements of then prevalent National Building Code and relevant IS Codes namely, IS 456, IS 1893, etc. appear to be followed.

Building may be used by school authorities at risk and responsibility of original structural consultant.
